



Payment Policy

Fees

Application Fee: Please note that there is a one-time, non-refundable Fee, payable at the time of application.

Tuition Fees: Fees are payable and due before the students' selected course begins. A 20% deposit of the total course is required to secure a place. {If the students chooses to purchase or attend another course thereafter, they will receive an alumni discount that can be used to contribute towards their next course}.

Entry Fees: There is a one-time, non-refundable Fee which is payable for each student.

Contract

The student agrees to pay all of the course Fees indicated in the Fee Schedule by the selected course date or, at the latest, upon receipt of the invoice. Course Fees may be paid in installments, according to the conditions set out below providing that the installment plan is in place before the initial due date. The payment of the Fees and other additional services is the responsibility of the student, regardless of any agreement that he/she may have concerning the payment of these Fees by a third party. Payments are acceptable in Pounds only and must be made via a bank transfer.

In the event that all or part of the sum due is not paid by the start of the course, and that installment payments have not been requested, a formal demand for immediate payment of the Fees shall be sent to the student. If payment is not made within 30 days of the date of dispatch of the demand, the student will not be accepted at entry date or will be suspended until such time as all of the Fees due have been paid.



Payment Policy

Failure to pay will result in the revoking of course privileges including but not limited to, access to classes, feedback, and the awarding of Certificates. The Student will be responsible for any legal costs incurred in the proceedings to recover the sums due. Brushstrokes Courses may also charge interest on late payments.

If the Student cancels the enrollment or re-enrollment by informing the Admissions Office in writing before the course date, he/she/they will not be liable for any payment, with the exception of the non-refundable deposit discussed with Brushstrokes Courses admin services. At the conclusion of the contract, Brushstrokes Courses may refuse to re-enroll the student if it deems that the Student is not respecting the regulations and values of Brushstrokes Courses and its services.

Financial Aid

PAYMENT BY INSTALLMENTS

Payment plan form can be requested from admin. Instalment payment request can only be accepted by Brushstrokes Courses if presented prior to due date of the course commencing. It is the policy of Brushstrokes Courses not to accept instalment payment when tuition fees are supported by a company, Embassy or any legal entity. Instalment payments are only accepted upon signature of the “mandat de prélèvement SEPA” (direct debit). If a request to pay in instalments is granted, 20% of the tuition Fee must be paid before entry into the course. The remainder will be paid through a “mandat de prélèvement SEPA” (direct debit), to be authorized before the course date in three equal instalments dated in payment plan contract.

An agreement “Brushstrokes Courses’ payment plan” must be signed by the student in order to take advantage of this program. Failure to will result in the revoking of course privileges including but not limited to, access to classes, feedback and the awarding of Certificates. If a payment is not made within 30 days of written demand sent from Brushstrokes Courses, the student will be suspended from any and all classes until all of the fees due have been paid.
